2. Applicability/Scope

3. Requirements

- Conducting a comprehensive analysis of our business activities' carbon footprint, as part of our integrated approach to combatting climate change and enhancing our sustainability performance
- Implementing a virtual-first business model to enable a remote workforce, thereby reducing our office footprint, employee commuting and business travel
- Pursuing efficiency programs for offices and data centers to reduce energy and water consumption
- Procuring renewable energy to reduce carbon emissions
- Reducing waste generation, increasing recycling rates and working with suppliers to minimize waste and harmful environmental impacts
- Offer training to grow the knowledge of our employees, ensuring they are aware of the environmental impacts of their work activities and encouraging them through regular awareness-building to minimize those impacts

- Promoting sustainability, environmental protection, prohibition of conflict minerals, and resource efficiency within our supply chain
